**Explanation of Responses:**

- Settlement of performance shares granted under the Republic Services, Inc. Amended and Restated 2007 Stock Incentive Plan based on Republic's closing stock price on 02/23/2021 (\$88.96).
- Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the settlement of performance shares on 02/23/2021. The fair market value of the exchanged shares was \$88.96 (the closing price of Republic Services, Inc.'s common stock on 02/23/2021).
- Restricted Stock Units ("RSUs") awarded pursuant to Republic Services, Inc. 2021 Stock Incentive Plan. The award will vest 25% on each of the first four anniversaries of the date of grant (which date of grant is 02/23/2021) and each RSU ultimately will be paid out in the form of one share of Republic's common stock. The number of RSUs was calculated based on Republic's closing stock price on 02/23/2021 (\$88.96). This grant is subject to the Republic Services, Inc.'s Deferred Compensation Plan as elected by the Reporting Person.
