On 02/23/2023, 25% of the grant vested and 145 RSUs remained deferred. As permitted under the Plan, the Company withheld 5 shares of Republic Services, Inc.'s common stock to satisfy tax liability of the Reporting Person. The fair market values of the exchanged shares was \$128.72 (the closing price of Republic Services, Inc.'s common stock on 02/23/2023).
- Each Restricted Stock Unit represents the contingent right to one share of common stock of Republic Services, Inc.
