- Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the vesting of 2,328 shares under a Restricted Stock Unit award. The fair market value of the exchanged shares was \$43.58 (the closing price of Republic Services, Inc.'s common stock on 02/05/2016).
- The Restricted Stock Units ("RSUs") granted on 02/08/2013 vest 25% on each of the first four anniversaries of the date of grant. 2,102 RSUs, that included accrued dividend equivalents, vested on 02/08/2016 and were paid out in the form of Republic Services, Inc.'s common stock.
- Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the vesting of 2,102 shares under a Restricted Stock Unit award. The fair market value of the exchanged shares was \$43.42 (the closing price of Republic Services, Inc.'s common stock on 02/08/2016).
- Each Restricted Stock Unit represents the contingent right to one share of common stock of Republic Services, Inc.
