- The Restricted Stock Units ("RSUs") granted on 07/30/2021 vest 25% on each of the first four anniversaries of the date of grant. 1,304 RSUs, that included accrued dividend equivalents, automatically vested on 07/30/2023 and were paid out in the form of Republic Services Inc.'s common stock.
- Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the vesting of shares under a Restricted Stock Unit award on 07/30/2023. The fair market value of the exchanged shares was \$151.50 per share (the closing price of Republic Services, Inc.'s common stock on 07/28/2023).
- Each Restricted Stock Unit represents the contingent right to one share of common stock of Republic Services, Inc.
