Explanation of Responses:

- Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the vesting of shares under a Restricted Stock Unit award on 02/23/2023. The fair market values of the exchanged shares was \$128.72 (the closing price of Republic Services, Inc.'s common stock on 02/23/2023).
- The RSUs granted on 02/23/2021 vest 25% on each of the first four anniversaries of the date of grant. 941 RSUs, that included accrued dividend equivalents, automatically vested on 02/23/2023 and were paid out in the form of Republic Services, Inc.'s common stock.
- Each Restricted Stock Unit represents the contingent right to one share of common stock of Republic Services, Inc.
