**Explanation of Responses:**

- The Reporting Person previously elected to defer a portion of the Restricted Stock Units ("RSUs") granted on 02/11/2022 in accordance with the Company's Deferred Compensation Plan (the "Plan"). On 02/11/2023, 25% of the grant vested, with 633 RSUs (including accrued dividend equivalents) remaining deferred in the DCP and 633 RSUs (including accrued dividend equivalents) automatically vesting and paid out in the form of Republic Services, Inc.'s common stock.
- Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the vesting of shares under a Restricted Stock Unit award on 02/11/2023. The fair market value of the exchanged shares was \$127.36 (the closing price of Republic Services, Inc.'s common stock on 02/10/2023).
- Each Restricted Stock Unit represents the contingent right to one share of common stock of Republic Services, Inc.
