#### **EXPLANATORY STATEMENT**

This Amendment No. 14 to Schedule 13D ("Amendment") amends and supplements the Schedule 13D previously filed by Cascade Investment, L.L.C. ("Cascade"), Bill & Melinda Gates Foundation Trust (the "Trust"), William H. Gates III and Melinda French Gates (together with Cascade and the Trust, the "Reporting Persons") with the Securities and Exchange Commission on July 21, 2008, as amended on August 1, 2008, August 18, 2008, September 22, 2008, December 16, 2008, January 15, 2009, January 29, 2009, February 9, 2009, February 23, 2009, March 3, 2009, October 30, 2009, November 5, 2010, August 18, 2011, and December 9, 2011, relating to the Common Stock, par value \$0.01 per share (the "Common Stock") of Republic Services, Inc. (the "Issuer"). Neither the present filing nor anything contained herein shall be construed as an admission that the Reporting Persons constitute a "group" for any purpose and the Reporting Persons expressly disclaim membership in a group.

Item 3. Source and Amount of Funds or Other Consideration

Cascade purchased 3,702,314 shares of Common Stock with its working capital for an aggregate purchase price of \$101,595,661.03.
