- Reflects dividend equivalents received on the 11,186 Performance Shares ("PSUs") earned as of 02/08/2019 per the Republic Services, Inc. Amended and Restated 2007 Stock Incentive Plan and such PSUs were deferred under the Company's Deferred Compensation Plan.
