**Explanation of Responses:**

- The Restricted Stock Units ("RSUs") granted on 02/18/2017 vest 25% on each of the first four anniversaries of the date of grant. 1,753 RSUs, that included accrued dividend equivalents, vested on 02/18/2021 and were paid out in the form of Republic Services, Inc.'s common stock. Does not include deferred RSUs that do not settle to common stock at this time (25% of initial grant was deferred under Republic's Deferred Compensation Plan).
- Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the vesting of shares under a Restricted Stock Unit award on 02/18/2021. The fair market value of the exchanged shares was \$91.72 (the closing price of Republic Services, Inc.'s common stock on 02/18/2021).
- The Restricted Stock Units ("RSUs") granted on 02/18/2018 vest 25% on each of the first four anniversaries of the date of grant. 2,134 RSUs, that included accrued dividend equivalents, vested on 02/18/2021 and were paid out in the form of Republic Services, Inc.'s common stock.
- Each Restricted Stock Unit represents the contingent right to one share of common stock of Republic Services, Inc.
