- Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the vesting of shares under a Restricted Stock Unit award on 02/14/2022. The fair market value of the exchanged shares was \$118.57 (the closing price of Republic Services, Inc.'s common stock on 02/14/2022).
- Each Restricted Stock Unit represents the contingent right to one share of common stock of Republic Services, Inc.
