The RSUs under this 01/03/2012 grant are immediately vested; however, the Director cannot convert any of the RSUs to Company common stock (based on 1 on 1 conversion) until the earlier of the last day of the month in which the three year anniversary of the date of the award occurs (for this grant being 01/31/2015) or the date on which the Director incurs a separation from service within the meaning of Section 409A of the Internal Revenue Code. This RSU award is directly held by the Director. The Director, as transferred to a Trust, further holds an additional 48,262 RSUs, that include dividend equivalents, as reported in previous Form 4 filings and such RSUs cannot be converted to Company common stock until his service as a member of the Board of Directors is terminated.
