- Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the vesting of 4,471 shares under a Restricted Stock Unit award. The fair market value of the exchanged shares was \$29.91 (the closing price of Republic Services, Inc.'s common stock on 01/04/2011).
- Each Restricted Stock Unit represents the contingent right to one share of common stock of Republic Services, Inc.
